

## Terms and Conditions Governing UOI Travel Promotion (1.1.2024 to 29.2.2024) (“Promotion”)

### 1. Promotion

- 1.1 This **Promotion** is organised by United Overseas Insurance Limited (“**UOI**”).
- 1.2 This **Promotion** is valid from 1 January 2024 to 29 February 2024 (both dates inclusive) (“**Promotion Period**”).
- 1.3 This **Promotion** is only applicable to new UOI Travel Single Trip Plans and Annual Multi-Trip Plans (“**Applicable Plan(s)**”) purchased from **UOI**’s website during the **Promotion Period** subject to the following terms.
- 1.4 For the purposes of this **Promotion**:
- (a) “**Eligible Customer**” refers to a customer who purchased an **Applicable Plan** during the **Promotion Period** and must meet **Promotion Mechanics** criteria stated in Paragraph 2 below.
  - (b) “**Card**” refers to any MasterCard or Visa credit or debit card or American Express card maintained with any bank or financial institution and which card is valid, subsisting, in good standing and satisfactorily conducted; and from which funds may be applied towards the payment of **Premium(s)** for any **Applicable Plan(s)**.
  - (c) “**Premium**” refers to the total insurance premium payable for the **Applicable Plan(s)**.
- 1.5 Participation in this **Promotion** is subject to these terms and conditions and the relevant insurance policy contract terms and conditions shall continue to apply as well. | Annual Multi-Trip | 20%                        |
- 2.2 The discount under this **Promotion** is not exchangeable for cash or other gifts in kind and is not valid in conjunction with any other promotion, discount or offer.
- 2.3 **UOI** may substitute the discount under this **Promotion** with any item of equivalent or similar value, without prior notice or reason or being liable to any person.

Individual Plan	\$25 for each insured person
Family Plan	\$25 for each plan

Cancellation of the Annual Multi-Trip Plan will be further subject to the short-term rate as stated in the policy terms and conditions.

### 3. General

- 3.1. **UOI** reserves the right in its sole and absolute discretion to change any of the terms and conditions of this **Promotion** at any time and from time to time without any prior notice or giving any reason or assuming any liability to any party.
- 3.2. **UOI** may, at any time and at its discretion terminate the **Promotion** and/or amend any of the **Terms**, and all persons shall be bound by such amendments.
- 3.3. **UOI** will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the participation in this **Promotion**.
